



**Terms & Conditions Import Airfreight**

**TERMS & CONDITIONS**

- 1 All quotations are exclusive of GST to be incurred on taxable supplies, where applicable.
- 2 The rates are applicable to General Consolidated Cargo only.
- 3 Weight / Volume Ratio is calculated at 1.6 ( 1 cubic metre (m3) = 167 kilos chargeable).
- 4 The maximum consolidated airfreight cargo dimensions are 300cm long x 220cm wide x 159cm high.
- 5 Airfreight Fuel Surcharges and Security Surcharge are subject to fluctuation with or without prior notice.
- 6 All quoted rates are current and subject to Airline tariff fluctuation with or without prior notice.
- 7 All quotations exclude Quarantine related fees, charges or expenses, if applicable.
- 8 All quotations are subject to a Cartage Fuel Surcharge which may be included or excluded at time of collection. This charge could vary at time of shipment.
- 9 Local cartage rates are subject to suitable site access and standard cartage procedures. Additional charges will apply for special vehicles, delivery or pick up procedures, permits etc.
- 10 Additional services outside the normal customs clearance functions shall be charged according to time and personnel required.  
International Transport Insurance is not included in any freight rates, therefore unless we are otherwise instructed, we understand that the responsibility of arranging insurance will be between your company and that of your supplier.
- 12 In accordance with your instructions we will arrange International Transport Insurance for shipments from (country / countries) to your warehouse. If insurance is no longer required, written confirmation is required.
- 13 A Forwarders Liability Insurance Fee is applicable for all consignments departing Germany.
- 14 A Forwarders Security Fee is applicable for all consignments departing Germany.
- 15 Where a Letter of Credit is involved, freight must be settled outside the Letter of Credit.  
We will issue one invoice covering all known charges at time of aircraft arrival. Payment of this invoice is required prior to release of your cargo. Further invoices will be applicable for any additional charges, if any and will require prompt payment.
- 17 Disbursement (i.e. Freight, duty, EEP Fee, taxes) require receipt of payment prior to cargo being delivered. All other charges (i.e. Customs Brokerage, and local Cartage) require receipt of payment within 30 days of invoice date (subject to credit approval).
- 18 Freight rates that are quoted in foreign currency will be debited in Australian Dollars (AUD).
- 19 Currency conversions are calculated at our exchange cost rate with an uplift of 4%.
- 20 Airfreight cargo classified as hazardous is subject to airline approval and requires, appropriate shipper's declaration and dangerous goods documentation.
- 21 General Consolidation rates are not applicable to hazardous cargo.
- 22 Quotations do not include the cost of fumigation. If fumigation is required at place of origin, an additional costing will be provided upon request.
- 23 All business is undertaken in accordance with our "Standard Terms & Conditions" published on our webpage and with the "Conditions" shown on the Airwaybill.
- 24 Personal effects are only accepted upon written confirmation.
