 - NIB, NPWP.
 - Permits – if required.
 - Original Commercial Invoice / Packing List / Insurance.
- All quoted charges and rates are payable in IDR (Indonesian Rupiah) based on Government tax rate on the invoice date.
- Shipment is assumed to be general cargo / non hazardous for transport by air/sea/road as per IMDG/ICAO/IATA and National Regulations unless specifically mentioned. The shipper must declare any dangerous or potentially dangerous goods.
- Our proposal is subject to acceptance of Our transport Bill of Lading / Air Waybill and Letters of Credit must be worded accordingly.
